Corporate Governance is now seen as an essential building block of stable economies. It helps to protect the rights and interests of shareholders and, increasingly, those of other stakeholders, providing a framework for effective monitoring of management actions and performance and for encouraging better business results. The challenge for SMEs and Family Businesses is that established Corporate Governance frameworks have been developed with large, listed companies primarily in mind.

Such frameworks and codes may not reflect the characteristics of the SMEs and Family Businesses, where owners may often be its managers as well, or where company ownership may be shared across family members. This is true for 87% of SMEs in India, which has been proved by research.

In general for SMEs and Family led Corporates, Corporate Governance is mainly about improving business efficiency and performance, and less about monitoring the actions of management. Therefore, what is the way ahead? There have been many suggestions in the past, like preparing a Mission and Vision Statement, Enterprise Succession Plan, Regular Audit and all Legal and Regulatory Compliance and so on. But what has been the implementation success? Let us get together to analyze, understand and improve in the days ahead.
